Corporate Structure

Currently, the Alliance for Clean Transportation (Alliance) is a part of the Northwest *Gas Association (NWGA)*, a 501(c) (6) organization with a mission to promote the use of natural gas to achieve energy, economic, and *environmental goals in the Pacific Northwest*. The NWGA's work aims to facilitate informed decision-making on natural *gas-related issues in the region*. All funds raised by the Alliance through memberships or other means are dedicated to supporting *its objectives, programs, initiatives, and staff*.

Organization Activities / Services

- Keep members informed about industry news and updates through regular *newsletters and communications*.
- Encourage collective industry action to promote NGV and Hydrogen fleet adoption.
